DISCUSSION:
The most recent schedule is attached.
Jacob's staff provides the following updates:
Traffic Update – Caltrans has approved the Traffic System Analysis Report.
Environmental Update – The Draft Environmental Report for Route Adoption was submitted to Caltrans and their internal reviews and QA/QC reviews have been completed. A response matrix addressing their comments is in process and edits being made. Caltrans Legal review remains in process.
Design Update – The submittal of the Draft PSR-PDS will be made to Caltrans and JPA early next month. Bridge Advance Planning Studies have been initiated for Draft PSR-PDS. Geotechnical, drainage, and storm water studies are all in process. Alignment geometric refinements continue. Note: Caltrans will not formally review the geometrics until CEQA Route Adoption has been approved. The Route Adoption Bill legislation (SB 532) is on schedule for the end of August.
Public Outreach – The revised corridor maps and public outreach summary have been

posted on the Caltrans website. Public was informed by "word of mouth". Meeting with ConAgra and additional property owners were held and minutes transmitted to JPA. The locations and dates for public hearings are being scheduled. The public hearing format has been confirmed with Caltrans and they will be in attendance at next NCC Board meeting to present at that time. A "dry run" for the public hearing is being scheduled and sample Q & A for public hearing are being developed. A presentation of project status and supporting resolution for the County was made at the July 21st Board of Supervisors' Meeting. Presentations of project status and supporting resolutions have been set for

the City Councils on the following dates: Oakdale on August 3rd, Riverbank on

August 10th, and Modesto on August 11th.
