DISCUSSION:

Don Peterson, the County Legislative Lobbyist has been working with Senator Cogdill's office to amend SB 532. This bill changes the limits of SR 108 to between Route 132 near Modesto to Route 120 east of Oakdale. The bill also identifies a portion of SR 108 as interregional, allowing it to be eligible for Interregional Transportation Improvement Program (ITIP) funding in the State Transportation Improvement Program. This designation will allow the NCC to be eligible for up to \$91M of ITIP funding as committed by Director Will Kempton. Senator Cogdill's office has requested local support of this bill in the form of resolutions from the JPA and StanCOG governing boards. Draft resolutions are attached for each agency.

On June 29th, the Assembly Committee voted unanimously to re-refer to Committee on Appropriations. Continued local support will enable this bill to stay on project schedule.

The following tentative adoption dates were identified at the July 1, 2009 Technical Advisory Committee (TAC) Meeting:

July 21st – Stanislaus County August 3rd – City of Oakdale August 4th – City of Modesto August 10th – City of Riverbank August 12th- StanCOG

Dear Senator Cogdill:

The North County Corridor Transportation Expressway Authority (NCCTEA) supports your Senate Bill 532 and sincerely appreciates the inclusion of the amendment related to State Route (SR) 108 in the bill. The NCCTEA, a joint powers authority with members from Stanislaus County, Cities of Modesto, Riverbank & Oakdale, Stanislaus Council of Governments and Caltrans, has embarked on a regionally important project that relocates SR 108 bypassing the cities of Oakdale & Riverbank.

As amended, your bill would redefine the limits of SR 108 as being between Route 132 near Modesto to Route 120 east of Oakdale. Current statute identifies a portion SR 108 as interregional, allowing it to be eligible for Interregional Transportation Improvement Program (ITIP) funding in the State Transportation Improvement Program (STIP). Your bill will include the portion of SR 108 within our project limits to be interregional, thus enabling it eligible for ITIP funding committed by the California Transportation Commission and Caltrans during the last STIP cycle.

These important statutory changes will allow the County and its partners to move forward on the critical bypass project, which will alleviate traffic problems in the northern part of the County.

Stanislaus County has been working for several years on this project. This statutory change will mark a major milestone. For these reasons, the NCCTEA is pleased to support SB 532 as amended, and extends sincere thanks and appreciation for your efforts on behalf of the County
