#### **GENERAL INFORMATION**

### **Behavioral Health Services Act (BHSA)**

Proposition 1, passed in March 2024, alters the Mental Health Services Act (MHSA) funding allocations to prioritize services for individuals with the most significant behavioral health needs and to fund treatment for substance use disorders and housing interventions. Included in its passage is renaming MHSA to the Behavioral Health Services Act (BHSA). Beginning in July 2026, funding categories will be restructured into three main areas: housing (30%), full-service partnerships (35%), and behavioral health services and supports (35%).

A survey is now available until September 30th, 2025, to collect valuable insights on demographics, lived experiences, and challenges related to mental health and substance use services. The input gathered will play a critical role in shaping the three-year BHSA Integrated Plan for Fiscal Years 2026-2027 through 2028-2029. All staff and contractors must adhere to strict guidelines ensuring privacy, security, and compliance with organizational, state, and federal regulations. The use of any other AI tools or applications requires prior written approval from the IT Department. The policy is available for review on the intranet.
