- Senate Bill 43, expanse the definition of gravely disabled to include substance use disorder will be implemented on January 1, 2025.
- CARE Court Act continue to meet monthly, with one agreement in place and 12-13 individuals have received housing and/or receiving care services.
- Board of Supervisors approved an agreement with the Board and Care facility in Turlock.

Mental Health Committee

Peter Dean reported the committee toured the Hutton House/Youth Navigation Center, a multipartnership of Stanislaus County which provides housing for the homeless and youth, as well as mental health services if needed.

Substance Use Disorder (SUD) Committee

Margie Johnson reported Sara Godfrey presented an overview of the services offered at Nirvana.

PRESENTATION: Substance Use Disorder (SUD) Youth Services

Paula McDowell, SUD Manager, provided a PowerPoint presentation focusing on Drug Medi-Cal Organized Deliver System (DMC-ODS) Youth services. BHRS administers a managed care plan for the treatment of substance use disorders to move towards parity with other health care systems to ensure adequate care for Medi-Cal beneficiaries with a substance use disorder diagnosis. The DMC-ODS is structured to provide services to both youth and adults. A copy of the PowerPoint was distributed to the members.

DEPARTMENT REPORT

Bernardo Mora, M.D., Medical Director, reported that community stakeholders continue to meet monthly to plan the implementation of Senate Bill 43, in partnership with local law enforcement, community partner agencies, Patient's Rights, and others.

Kevin Panyanouvong, Associate Director, reported the following highlights:

- SB43 is on target to be implemented on January 1, 2025.
- The 24/7 Mobile Crisis Unit contracted with Telecare is completely operational as of May 15, 2024, covering the entire county. For mobile units, call the Access line at 1-888-376-6246.
- BHRS is collaborating with County officials to develop a plan to minimize the Incompetent to Stand Trial (IST) CAP The State is penalizing the county \$450,000 for numbers above the 21/22 CAP.

ANNOUNCEMENT

Melissa Farris, Behavioral Health Family Advocate, announced there are now two-family groups on Mondays at 5:30 p.m. held at 500 N. 9th St., Modesto, for families dealing with family members with serious bound illness.

Olivia Esquivez Gonzalez shared that veteran meetings for Stanislaus County's westside will begin in January 2025. She and Jorge Martinez, a journalist and veteran, will collaborate to implement services in the westside. At this time Olivia will be attending veteran meetings in Modesto.
