DISCUSSION:

This is a request to set a public hearing for December 9, 2025, at the 9:00 a.m. meeting, to consider the Planning Commission's recommendation for General Plan Amendment Application No. PLN2022-0045 – 6th Cycle Housing Element Update. The proposed 2023-2031 Housing Element includes goals, policies, objectives and programs to further opportunities for housing to households in the unincorporated areas of Stanislaus County. No development project is proposed as part of the Housing Element Update. This project is considered exempt from the CEQA.

The Planning Commission will consider this item at a public hearing on October 16, 2025, to provide the Board of Supervisors with a recommendation. This item will set the date and time for a public hearing for the Board of Supervisors to consider the Planning Commission's recommendation.

POLICY ISSUE:

An update to the Housing Element is needed every eight years in order to maintain compliance with California's Housing Element Law requirements, which may be used to determine eligibility for state funding. The California Department of Housing and Community Development is responsible for determining whether a jurisdiction is in compliance with Housing Element law, which requires a certified housing element and adopted rezone program.

To consider amendments to the County's General Plan and the Zoning Ordinance, and to rezone parcels, the Board of Supervisors must hold a public hearing. As allowed by

California Government Code Section 65358, the General Plan may be amended up to four times per year. In accordance with Stanislaus County Board of Supervisors Resolution No. 85-1673, adopted October 29, 1985, General Plan amendments may be considered by the Board of Supervisors in the months of April, August, and December, and up to one additional time during the calendar year to be set by the Board of Supervisors.

FISCAL IMPACT:

Costs associated with processing of this Housing Element update are covered by various state grant funds, funds available to the Planning and Community Development General Fund Legal Budget, and General Plan Maintenance Fee funds.

BOARD OF SUPERVISORS' PRIORITY:

Approval of this action supports the Board's priorities of Supporting a Strong and Safe Community, Supporting a Healthy Community, Developing a High-Performing Economy, Delivering Efficient Public Services, and Enhancing Community Infrastructure by meeting state Housing Element requirements.
