**USE PERMIT APPLICATION NO. PLN2023-0047 – BEST RV CENTER** SUBJECT:

After the publishing of the October 17, 2024, Planning Commission Staff Report for the subject application, the applicant requested a revision to Condition of Approval No. 4, to allow for greater flexibility in the timing to complete the project. The applicant's request described needing six months for design and permitting, six months for demolition and site preparation, and 24 months for construction and site development, for a total of 36 months. Accordingly, staff is proposing the following amendment to Condition of Approval No. 4 to modify the required timing of issuance and completion of all permits (added text is shown in bold font and deleted text is shown in strikeout):

4. Completion of Issuance of all permitting for Phase 2 shall be no later than 18 months, with completion of all permitting no later than 36 months from project approval, unless extended as permitted under P-D (351).

## RECOMMENDATION

Staff recommends the Planning Commission provide a recommendation of approval to the Board of Supervisors, as outlined in the October 17, 2024 Planning Commission Staff Report, with the amendment to Development Standard No. 10 as outlined in this Planning Commission Memo.
