1. Call to Order and Introductions

Chief Probation Officer Mark Ferriera called the meeting to order at 1:32 p.m., and members of the group introduced themselves.

2. Public Comment

No one provided public comment.

3. Adoption of Minutes from September 14, 2023, and November 30, 2023, meeting

MOTION: District Attorney Jeff Laugero. SECOND: Public Defender Jennifer Jennison. The minutes from the September 14, 2023, and November 30, 2023, meeting were approved unanimously.

4. Sheriff's Office Presentation (PowerPoint Presentation is attached)

Lieutenant Timothy Burns and Deputy Aaron Thomas presented on the Sheriff's Office Inmate Programs. The Sheriff's Office has partnered with various community-based organizations to provide the incarcerated population with educational and vocational programming. The presentation included the following:

- Adult Detention Facilities
- Educational Classes
- Community Partnerships
- Financials
- Classes and Enrollees Year-to-Date Data
- Learning Quest Highlights
- Programs and Participation
- Program Highlights
- Future Programming
 - The Sheriff's Office is partnering with local community agencies to enhance vocational training for the in-custody population. Participants will receive certifications upon completing the courses. The training will include Servesafe, Window Tinting, Truck Driving, Construction, HVAC, and Cosmetology.

5. Public Defenders Presentation (PowerPoint Presentation is attached)

Client Support Services Manager Shelli Margarite and Client Support Specialist Gabby Verduzco from the Public Defender Client Support Services Office gave a presentation on the services they offer the community. The presentation highlighted their commitment to assisting clients from all walks of life by connecting them with the necessary services to keep them out of custody. They service individuals needing early representation, juveniles, veterans, people experiencing homelessness, and post-release clients.

6. Program Update:

Realignment Manager

Realignment Manager Michael Walker from the Probation Department reported that client attendance and successful completions at the Day Reporting Center (DRC) continue to increase.

The tattoo removal program will be held at the Day Reporting Center on March 19, 2024, and May 7, 2024.

Regional Apprehension Team (RAT) operations continue. The most recent RAT Op was partnered with the Modesto Police Department, and additional RAT Ops are forthcoming.

CARE:

Data Analyst Vanessa Bravo from the Probation Department reported the following services provided for the 2nd Quarter of FY 2024 were as follows:

- 456 Food and Clothing
- 182 Transportation
- 158 DMV
- 397 Medical
- 186 Mental Health
- 175 Substance Use Disorder (SUD)
- 245 Life Skills Counseling
- 158 Social Security
- 140 Housing
- 60 Assessment
- 15 SUD Assessments
- 850 individual contacts. An average of 250 individuals were served per month.

District Attorney:

District Attorney Jeff Laugero announced that Patricia Sanchez had been promoted and would no longer attend the CCP meetings. Moving forward, Courtney Marton will report on behalf of the District Attorney's Victim Advocates Office.

From December 2023 to March 2024, 148 victims received information for restitution. During this same period, probation contacted their office 205 times for victim names and information, copies of Criminal Protective Orders (CPOs), and restitution information.

Behavioral Health & Recovery Services (BHRS):

Tony Vartan reported the following:

Collaborative Courts Update: BHRS, partnered with the Public Defender's Office, the DA's Office, and other justice-related departments, are discussing the need to expand caseloads.

Early Response Team: The Early Response Team is on stand-by pending court rule discussions between the Public Defender, District Attorney, and Courts.

Public Defender's Office:

Jennifer Jennison reported that the Board of Supervisors approved CCP funding to start the Homeboy Industries-inspired reentry program. Mr. Michael Baldwin, Legacy Alliance Outreach Founder & CEO, was awarded the contract for the program. Ms. Jennison noted that a client support specialist will be embedded into the program and must pass background checks to be flexible in connecting with people in and out of custody. BOS Terry Withrow pointed out that a building was donated to house the program; the address was not disclosed.

Workforce Development:

Doris Foster reported the following:

Workforce Development receives referrals from Parole; they served 122 previously justice-involved individuals, 45 of whom were employed. The average hourly wage was \$21.16.

Ms. Foster also noted that Workforce Development is facilitating Juvenile Probation programming at their downtown Modesto location due to the limited space at the Juvenile Probation Office. They currently have 17 youths attending.

Community for Services Agency (CSA):

Latosha Walden announced that San Joaquin Street Meds was invited to Stanislaus County to help build up Cal AIM initiatives. Cal AIM pays for San Joaquin Street Meds; all billing will go through them. They will give a presentation at the next CSOC meeting. Anyone interested in attending is welcome. The meeting will be held at Harvest Hall, 3800 Cornucopia Way, Modesto, on Thursday, March 21, 2024, from 2:30 p.m. to 4:30 p.m.

Center for Human Services Agency:

Gina Machado reminded everyone that the Center for Human Services is accepting referrals for substance use disorder.

Leaders In Community Alternatives:

Consuelo Guzman provided the following update:

- CBI-Employment Adult: 33 participants were enrolled in CBI-Employment processing between modules 1-4.
 - New classes start every 2 weeks; 11 clients are in the Job Search module.
- Employment: 9 participants are currently employed full-time with retention tracking.
- Vocational: 8 participants currently attend a vocational program: 4 at J&R Trucking, 3 at DeHart HVAC/R, and 1 at Volt Institute Electro-Mechanical.
- Vocational Completions: 14 participants completed a vocational training program in the last 90 days: 1 completed J&R Truck School, 1 completed Cal Trade Welding Program, 4 completed ServSafe, and 8 completed Forklift Training.
- CBI-EA Completions: In the last 90 days, 15 participants completed the CBI curriculum.

- LCA Graduates: In the last 90 days, 7 participants completed and Graduated LCA and remain employed full-time.
- ART: In the last 90 days, 7 participants completed. 8 are scheduled to be completed on 5/2/24.
- REACT: 4 CBI-Employment groups are being facilitated: General Population, Protective Custody, women, and Veterans.

7. Announcements:

Chief Ferriera announced that the representative appointment would be on the agenda for consideration. This included accepting Cindy Duenas' CCP membership resignation pending her retirement as Director of the Center for Human Services and potentially voting on her replacement.

The presenter scheduled for the next meeting is the District Attorney's Office.

About the Public Defender's Office:

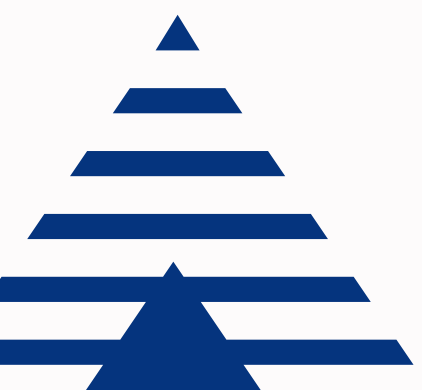
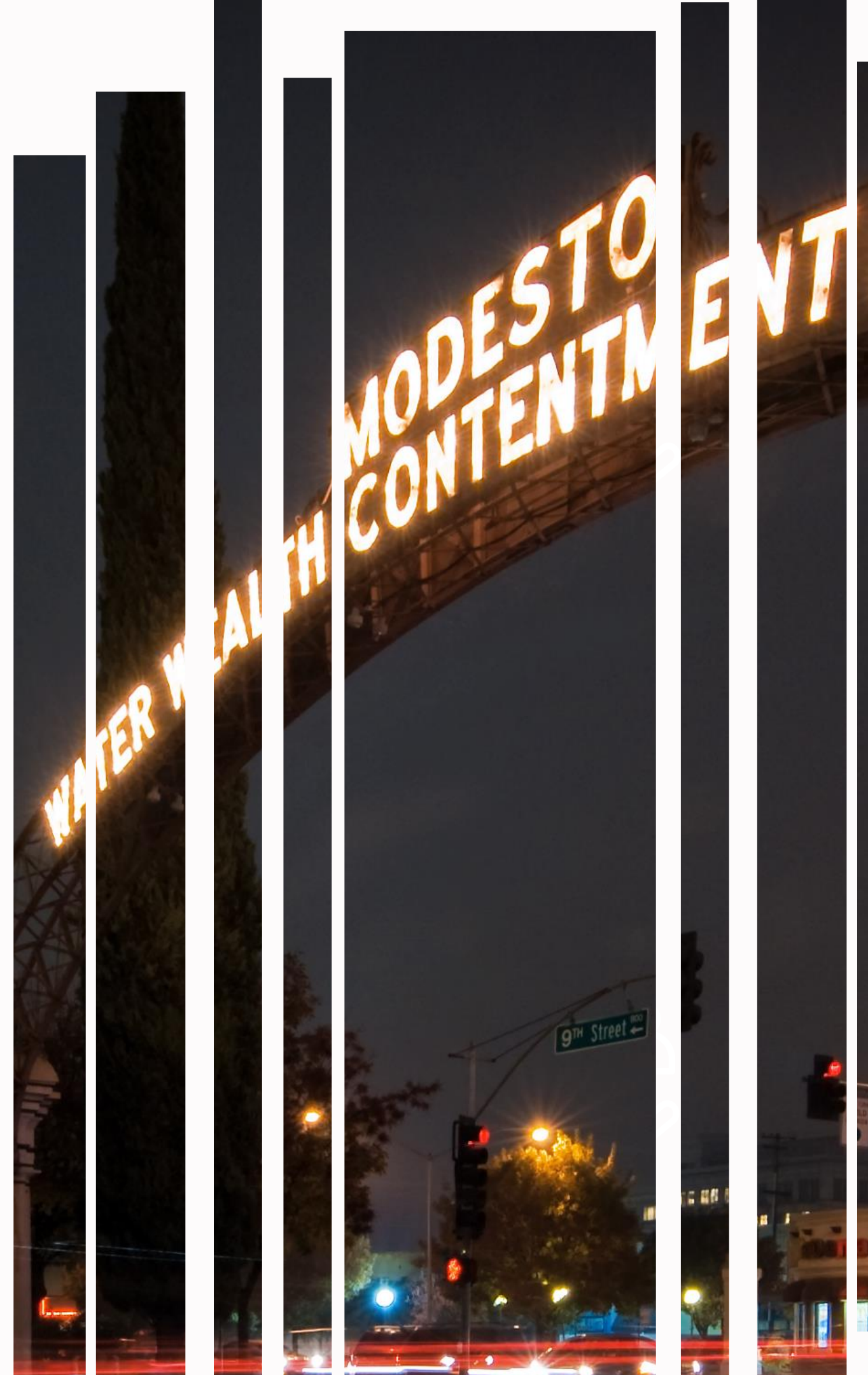

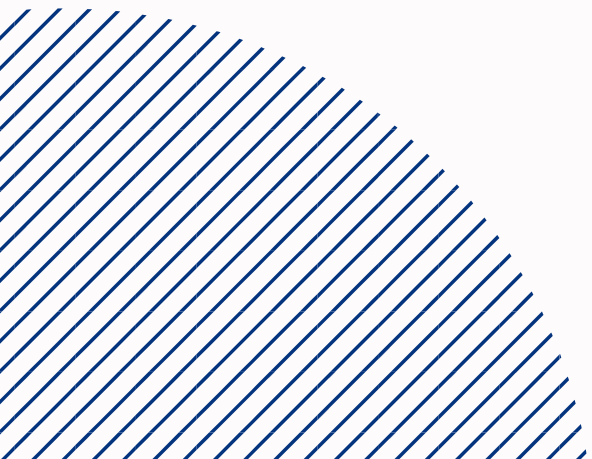
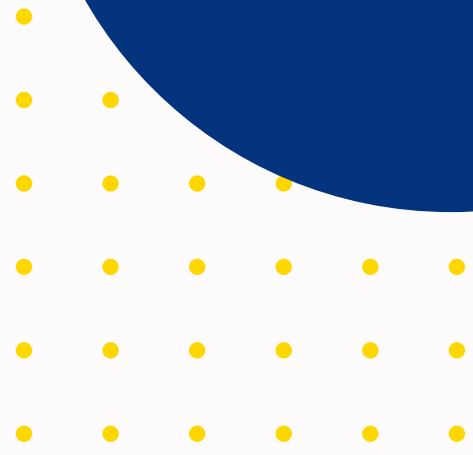


Client Support Services Unit

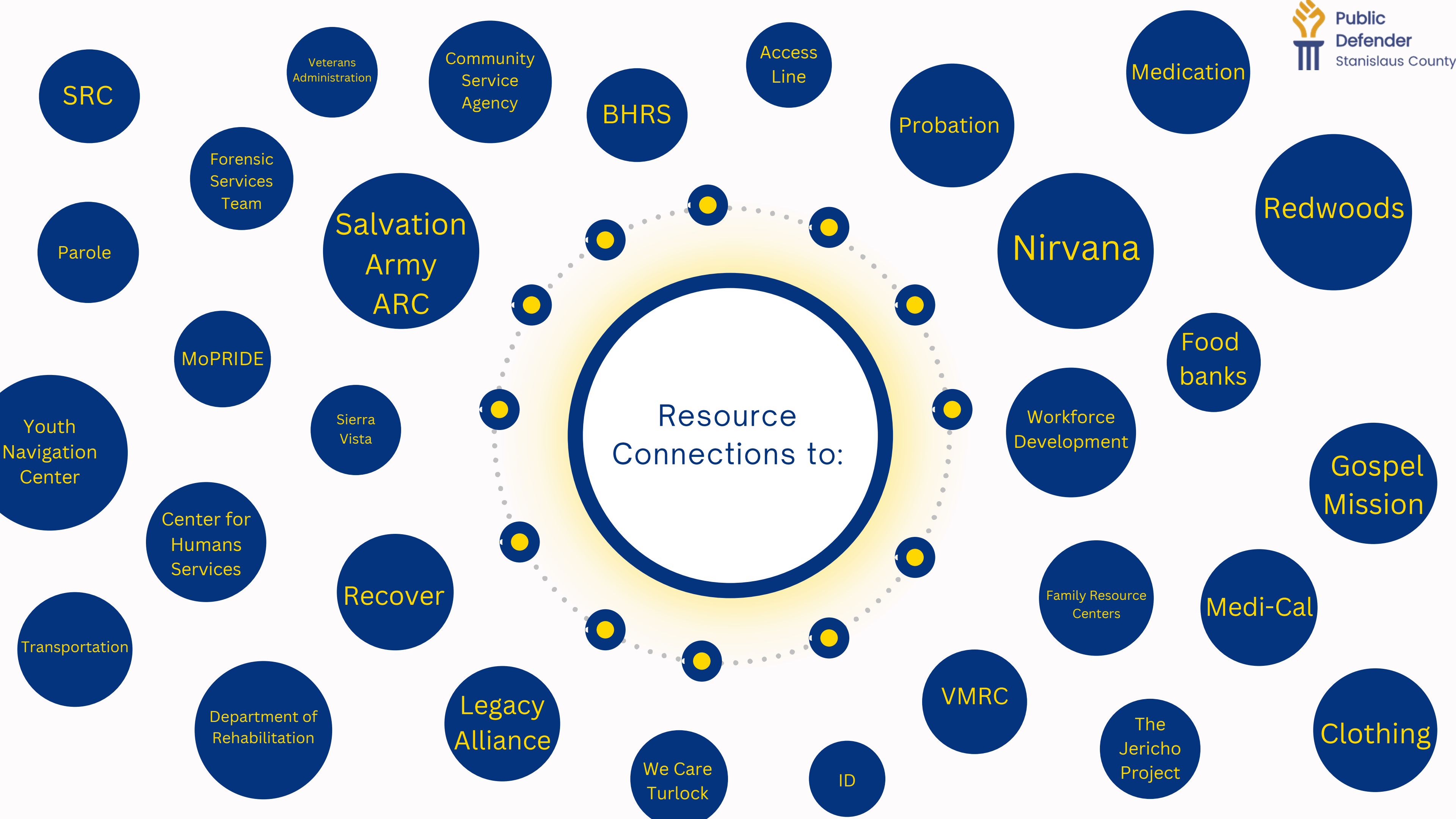

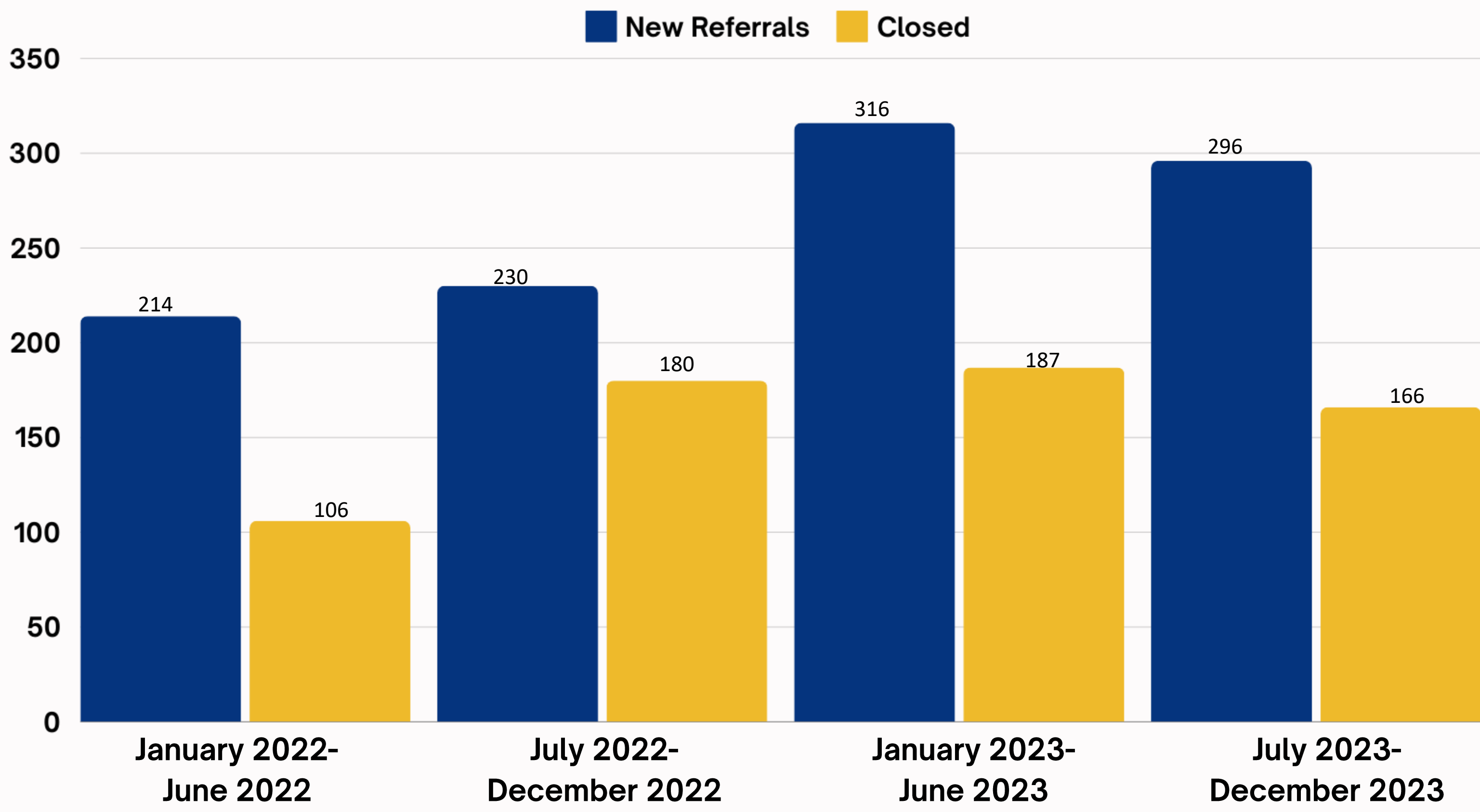

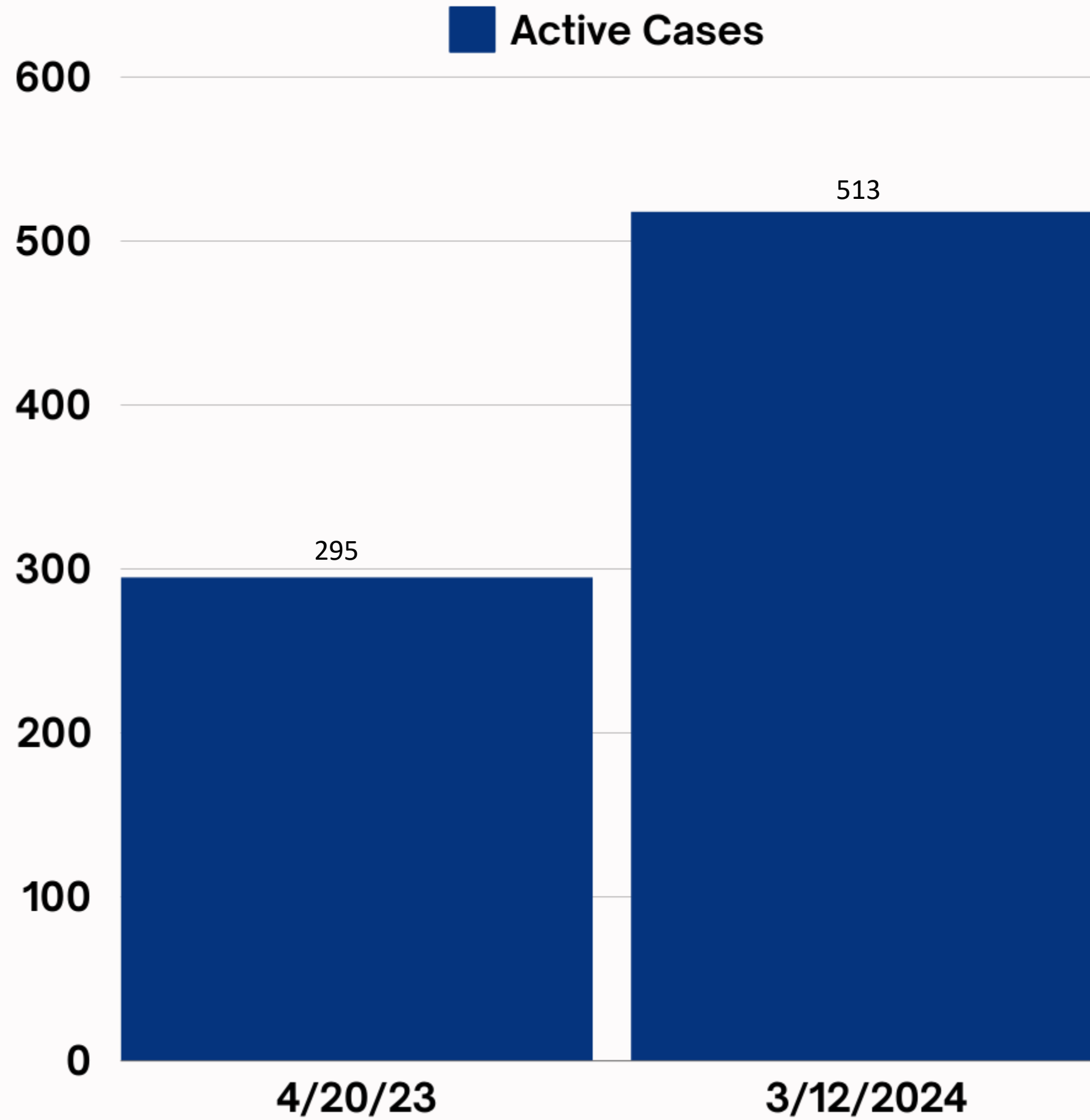

Client Testimonies

Mr. Rick Jones



Mr. Jones has been in and out of jail and prison for the past 18-years. Mr. Jones has struggled with substance use disorder for over 20-years. In his most recent justice-involved case, the Public Defender (Stanislaus County) provided his legal defense. The Public Defender's office was able to get Mr. Jones a deal for a drug program in leu of jail or prison time. Client Support from the office of the Public Defender assisted Mr. Jones with program placement. Mr. Jones entered treatment at the Stockton ARC program per his agreement with the court to complete a 6-month residential program. After 3-months Mr. Jones left the program. However, Mr. Jones contacted Client Support seeking assistance. Client Support assisted Mr. Jones with returning to the Stockton ARC program. The court was even gracious enough to allow Mr. Jones another chance to complete the 6-month program. In total, Mr. Jones was at the Stockton ARC program for 9-months. Mr. Jones' recent case is now closed. Client Support has connected Mr. Jones to the Valley Build Apprenticeship Program. This training program will lead to gainful employment with a union job.

"I want to thank the Public Defender and the court for giving me a chance. Instead of prison I went to a program, and it changed my life. It helped me to better myself in a positive way. I have hope for a better future and a better me. I am currently enrolled in the Valley Build program, and this will lead to a good job. This is such a great opportunity that I never dreamed of having. Thank you for the support!"

I was asked to give a brief account of the support and help I have received from the Public Defender's Office through the Veteran's Treatment Court. I also want to personally thank Mr. Martin Velasco and Neil Zientek for their help with meeting all my personal goals and obligations. **They have been huge supports in my times of need.** I've been battling my addiction for seventeen years and it has gotten me in and out of trouble with the law and I've sent to prison four times due to it. With this opportunity through the Veteran's Treatment Court, Probation Department, and the Public Defender's Office, I've been able to go to rehab, complete my PHP [partial hospitalization program] program, and am currently enrolled in an IOP [intensive outpatient program]. Due to the support I've received, **I've managed to pull eight months of sobriety,** which I had not been able to do on my own. **Martin has been there every step of the way** to help and guide me on my path to recovery and I am very grateful for the help he has given me. Now that I am sober and have a clear mind, I want to get into the career of helping others by possibly becoming a substance use counselor. I'm slowly getting back on my feet, starting with a safe and stable place to stay, and my family back in my life, and I now have healthy friends and relationships. **Thank you again for being the support system that I needed to make this change.**

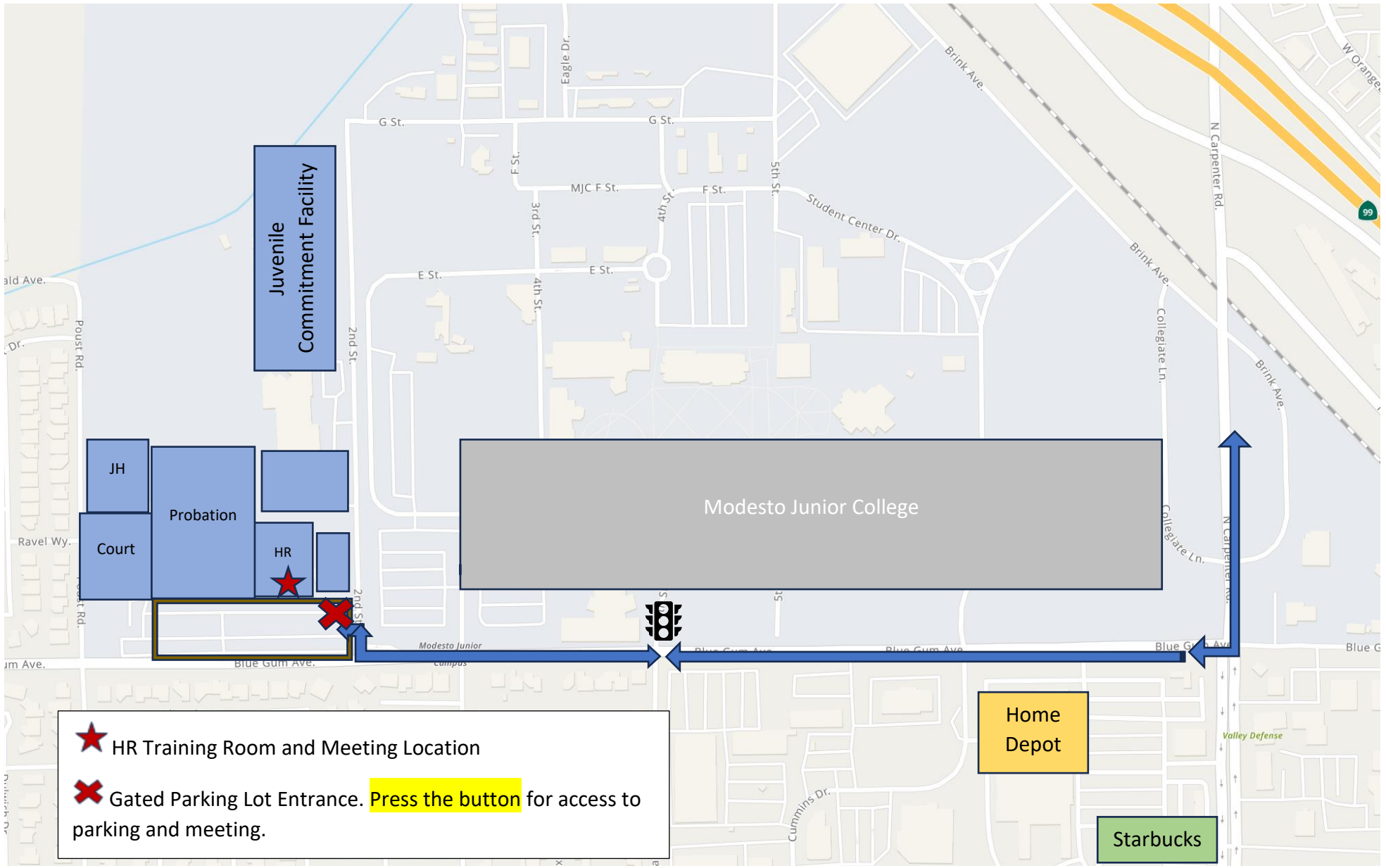
